A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON APPROVING A LETTER OF AGREEMENT WITH TEAMSTERS LOCAL #760 – Police Support

WHEREAS, in January 2016, the City Council of the City of Sunnyside approved the January 1, 2015 to December 31, 2016 Collective Bargaining Agreement (CBA) with Teamsters Local Union No. 760 – Police Support Unit by way of Resolution 2015 - 45; and

WHEREAS, the parties have agreed to a Letter of Agreement regarding adding Crime Analyst/Evidence Technician from non-bargaining classifications to bargaining; and

WHEREAS, the City Council finds and determines that approval and ratification of said agreement is in the best interest of residents of the City of Sunnyside and will promote the general health, safety and welfare.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

SECTION 1. That the Letter of Agreement, a copy of which is attached hereto as Exhibit “A” and incorporated herein by this reference, by and between the City of Sunnyside and Teamsters Local 760, is hereby approved.

SECTION 2. The City Manager is hereby authorized to execute and administer such agreement for and on behalf of the City of Sunnyside.

SECTION 3. This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.



LETTER OF AGREEMENT

**BY AND BETWEEN
CITY OF SUNNYSIDE
AND**

TEAMSTERS LOCAL UNION NO.760-POLICE SUPPORT

**ADDITION OF CRIME ANALYST / EVIDENCE TECHNICIAN
TO POLICE DEPARTMENT SUPPORT BARGAINING UNIT**

- A. The City of Sunnyside, hereafter called the "Employer", is a municipal corporation of the State of Washington, with city hall located at 818 E Edison Avenue, Sunnyside Washington 98944.
- B. The Teamsters Local Union No.760 - Police Support, hereafter called "Union", is the exclusive bargaining representative for the bargaining unit employees consisting of Police Support Employees for the City of Sunnyside.
- C. The Parties agree that the classification of Crime Analyst / Evidence Technician currently exists within the Police Department as a non-represented position. Job duties and responsibilities have been modified, removing "Administrative Assistant to the Chief of Police". The Crime Analyst / Evidence Technician is a non-sworn Police Department Support Division position; working within the same command structure and physical facilities as other Support Division employees.
- D. Effective January 1, 2016 the Crime Analyst / Evidence Technician classification shall be recognized and included into the Police Support Bargaining Unit.
- E. Effective January 1, 2016, the base salary of the Crime Analyst / Evidence Technician shall be increased by One hundred seventy-five dollars (\$175.00) per month added to base wage. All other terms and conditions of the Police Support Collective Bargaining Agreement shall apply.

Entire Agreement. This Letter of Agreement constitutes the entire agreement of the Parties regarding the addition of this classification.
