**AN ORDINANCE OF THE CITY OF SUNNYSIDE, WASHINGTON,
CREATING A NEW CHAPTER 1.13 ENTITLED "OFFICIAL CITY FLAG"**

WHEREAS, the City of Sunnyside prides itself on its bountiful sunshine; and

WHEREAS, the City of Sunnyside has long provided a cornucopia of fruits, vegetables, and grain to the nation, and

WHEREAS, the City of Sunnyside wishes to commemorate its agricultural heritage through a City Flag, and

WHEREAS, the City Council has selected and commissioned a design presented by the Sunnyside Arts Council which depicts Sunnyside's heritage,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, DO ORDAIN AS FOLLOWS:

SECTION 1. A new Chapter 1.13 entitled "Official City Flag" of the Sunnyside Municipal Code is hereby created and shall read as follows:


Sections:

1.13.01 **Official Flag Established.** The official flag of the City of Sunnyside shall be a banner of light blue on the top fading to dark blue on the bottom. The flag shall have a circular image in its center depicting Sunnyside's agricultural diversity. The image shall be that which was created by artist Kathleen Rogers in 2015. The words "City of Sunnyside Washington EST. 1902" shall be inscribed around the circumference of image.

1.13.02 **Display of the City Flag.** The City Flag shall be displayed at all City of Sunnyside offices. The flag may be displayed on special occasions as deemed appropriate by the City Manager or City Council.

SECTION 2. This Ordinance shall be in full force and effect five (5) days after its approval, passage and publication as required by law.
